1. The approved rates will be converted into rate contract valid upto 31.12.2024. No price increase will be allowed during the currency of rate contract.

2. The tenderers are required to use separate tender form for quoting the rates for Chemicals/Glassware/Plasticware/Miscellaneous Lab & Field Items (Except Equipment

& Instrument), as the case may be.

3. Each tender should be accompanied with a Bank Draft of Rs. 3000/- in the name of Comptroller, UH&F, Nauni, Solan drawn only on the State Bank of India, Nauni/UCO Bank, Nauni as tender fee (non-refundable) and an Earnest Money of Rs.20,000/- in the shape of FDR pledged in favour of Comptroller, UH&F, Nauni, Solan (HP), which shall be returned to the unsuccessful tenderer(s).

4. The firms will supply a sealed and signed copy of price list for which they have quoted their rates. The tender received without the requisite price list(s) may not be considered. The successful tenderers will provide thirty price lists for which they are awarded rate contract for signing by this office, and further supply to

the Indenting Offices.

5. The authorized dealers/stockiest are required to submit with their tender a specific authorization certificate from the manufacturer, addressed to the Comptroller,

6. 7. The supplies are required to be effected FOR destination at the main campus as well as the Research Stations & KVKs located in each district of Himachal Pradesh.

- 8. The supplies will have to be effected within a month from the date of supply order by the individual Indenting Officers. However, where the goods are urgently required by the indentor the firm will endeavor to fulfill the demand.
